# MS 3147/3/458 CORNISH MINES & ENGINES CORRESPONDENCE & PAPERS 1777— CIRCA 1801

#### INTRODUCTION

This bundle contains letters, memoranda, calculations etc. about various individual Cornish mines and their engines. The original arrangement of this bundle is not clear, but at some point the contents have been arranged alphabetically by mine. The contents of this bundle were almost certainly gathered together from various other sources, but it is not clear when this happened.

The papers concern the ordering, erection and performance of engines, mine shares, debts owed to Boulton & Watt, disputes over payment, etc. A large number of the papers relate to the legal actions against the "recusant" mines in the late 1790s, and Matthew Robinson Boulton's visit to Cornwall in 1799 to settle with various mines. These engines were referred to as the "Eastern engines." The tests to establish this standard performance were made in August and September 1778.
